On January 15, 2008, at 7:40 p.m., Dorothy Devine died from respiratory failure. Dorothy had been in poor health since mid-2004. Dorothy's husband, Jim, and her family were at her side throughout her last hours, and she helped plan her memorial service, which was held on January 19. Dorothy was interred at Spring Hill Cemetery in Nashville,

Dorothy's son, Don Layton, writes: "My mother, like many of you, lived a life of joy, misery, challenge, and happiness. She was a strong woman who, throughout her life, worked hard, taught me independence, and cared for my brother Jimmy before he died. The sum total of her life would be best described as 'she was a person who enjoyed

her friends, loved her husband, and cared for her family.'

"Mom was born September 12, 1928. She was a nurse practitioner, working with a pediatrician for many years. When I was 16, she married Jim Devine. After a few years in Nashville, they moved to California, first residing in Long Beach and later in Mission Viejo. Their great adventure began when Jim retired and they became full-timers. It was this joint venture where they made friends with you, their fellow pilgrims of the roadway.

"On many occasions Mom spoke with great pride of the Discovery club. I am pleased and honored that you will remember her at the rally this fall. I know that she is traveling that heavenly highway, and she would want to say to all of you who were her friends, 'Keep your eye on the road and I'll see you again someday."

Dorothy and her husband, Jim, founded Discovery Owners Association, Inc. ten years ago this coming April. Her gentle spirit, cheerful smile, and kindness to all will be sorely missed. Please join us in September to pay tribute to a fine lady.

### Audit Committee Report

#### Report Dated February 8, 2008 ..... by Steve Masterson, Buddy Reynolds, Toni Calzone

The audit committee (DOAI members Steve Masterson, Buddy Reynolds, and Toni Calzone) met with DOAI Treasurer Micky Racer on January 26, 2008 to conduct the 2007 DOAI audit. The committee interviewed Micky and began to review the financial records. During the review, we discovered that Micky brought the 2006 bank records rather than the 2007. The committee is working with Micky to find a way to review the 2007 records. In the interim, the audit committee submits the following recommendations to the DOAI executive committee. The final report will be submitted upon review of the 2007 records.

DOAI audit committee recommends the executive committee:

- Establish a standing audit committee comprised of three DOAI members who are not members of the national executive committee. The members should be appointed to a one-, two-, and three-year term to ensure turnover and continuity.
- Create a new vice treasurer position to be elected by the general membership. The vice treasurer shall shadow the treasurer, fill in for the treasurer when needed, and serve as treasurer when the term ends. Both positions, vice treasurer and treasurer, should be elected by the general membership.
- Establish written procedures for the financial accounting process to include internal controls to ensure that proper checks and balances are in place to safeguard DOAI's fiscal soundness, a time line for annual audits, guidelines and requirements for DOAI chapters.

- Require DOAI chapters to provide the national board with an annual financial report, due by March 1 of each year. The reports must include any interest earned so it can be reported by national. Currently, this is not the practice and could jeopardize DOAI's tax-exempt status.
- Notify chapters that any funds raised by means that are considered gambling, i.e, 50/50 raffles, are to go to a recognized, incorporated charity. Tax-exempt organizations are not allowed to raise funds via gambling.
- Provide the audit committee read-only access to DOAI bank accounts.

### Silent Auction Planned for 2008 National Rally

A new-to-DOAI-rallies event is planned for our tenth anniversary rally this coming September: a silent auction. The call is out for those who create handmade items to consider donating one to the auction. The auction also seeks contributions of new items and collectible items in good condition.

All proceeds from the auction will be donated to 4 Paws for

Ability<sup>TM</sup>, Inc., an agency in Xenia, Ohio, which trains and provides service dogs.

Why 4 Paws? When Dorothy Devine was planning her memorial service, she told her family that she would rather people make a contribution to a charity than send flowers for her funeral. One of Dorothy's favorite good causes are those agencies which train and provide service dogs. After doing considerable research, the rally committee agreed that 4 Paws for Ability<sup>TM</sup>, Inc. would be a worthy recipient of the funds we raise (and the proceeds from the usual 50/50 game will also go to 4 Paws).

4 Paws for Ability believes service dogs should be made available to anyone with a disability who wishes to have the love, companionship, and independence that are the result of service dog placement. 4 Paws specializes in placements with people who are turned away by many other agencies. They have no eligibility requirements beyond a physician's statement that the person requesting a service dog has a disability as defined by the Americans with Disabilities Act of 1990. 4 Paws finds creative, innovative means of assisting

people with severe disabilities with solutions.

Oftentimes people with disabilities contact agencies that place service dogs only to be told they are too disabled or not disabled enough and are turned down. Also, parents trying to find service dogs for their children quickly discover that many agencies will not place service dogs with children. In addition, many agencies won't place service dogs in homes where there

are other pets, and state that if they want a dog they have to get rid of their current pet companions.

For these and other reasons, 4 Paws for Ability<sup>TM</sup>, Inc. offers a variety of training for assistance dogs. The types of dogs 4 Paws trains include hearing ear dogs, autism assistance dogs, multipurpose assistance dogs, mobility assistance dogs, and seizure assistance dogs.

Several people have already signed up to contribute items to the silent auction. If you

### Secretary's Report

#### January 2 and January 26, 2008 ......

n January 2, 2008, your board of directors met electronically and ratified the recent election results. The following officers were installed: President Marshall Godwin; Executive Vice President John Baker; Vice President of Development Phil Yovino; National Rally Master Jay Keneson; Treasurer Miriam (Micky) Racer; Secretary Elsie Sikes. There was no further business conducted at this time.

The secretary was unable to attend the Southeast Region rally in Seffner, Florida. The following synopsis has been developed from minutes of the DOAI board meeting as recorded by L. Carlyne Krauter:

- Meeting held January 26 with the following present: Marshall Godwin, Phil Yovino, Jay Keneson, Micky Racer, and region vice presidents Frank Cason, Charlie Richardson, and Joe Stewart.
- President welcomed those present and thanked the Florida Rolling Gators for hosting the regional rally.
- Minutes were read and accepted for the board meetings held November 9, 2007 and January 2, 2008.
- Treasurer's report showed the total bank assets of just over \$71,000 and the 2007 audit is underway. Treasurer advised that each chapter that uses the DOAI Tax ID number needs to submit an end-of-year statement indicating that no income was earned, or provide documentation for any earnings. She will develop and provide a sample statement to the chapters.
- Based on shortfall from the last national rally, processes and procedures were discussed to strengthen steps to provide timely notification for unexpected expenses in order for the board to approve the over-budget expenditures. Controls used at the next national rally were reviewed.
- Jay Keneson and Dick Snyder presented plans for the tenth anniversary rally in Goshen, Indiana, during September. The draft rally registration form was reviewed. Jay offered his input for the rally handbook being developed and

significant sections for the handbook were assigned to board members with a request their drafts be submitted to Jay by February 29. He will consolidate the inputs and distribute a draft for the rally handbook by March 31.

- Phil Yovino provided a sample of the logo and material to be used for Secretary Elsie Discovery flags. The board approved the purchase of 300 flags which will be given (one per
  - coach) to those attending the 2008 national rally. Any remaining flags will be available to purchase as DOAI merchandise.
- The ability to join DOAI online as well as for members to pay their dues has been implemented.
- A motion was made and approved to expand Website access for associate members to include Hints & Tips and Modifications.
- The board agreed to delay any changes in the standing rules regarding major rally financing until this section of the rally handbook has been approved.
- The board is seeking a volunteer to handle a test or trial that will allow members to purchase DOAI merchandise through the newsletter or the DOAI Website.
- A motion was made and approved for the Webmaster to develop and submit a plan to the board for members to register and pay fees online for regional and national rallies.
- A proposal to modify standing rule #12 was proposed which would prevent one person from holding more than one position on the board. Since this had happened because the nominating committee could not find sufficient candidates for open positions at the recent election, the board unanimously approved the deviation. The board feels that instead of changing the standing rule, more people should be encouraged to stand for the open offices.
- Meeting adjourned.

### Emma, Bubbles, and Me

### 

Y daughter, Emma Walker, has a companion named Bubbles, and therein lies the tale...

Bubbles is a Labradoodle – half Labrador retriever and half

standard poodle. He definitely got the best of both halves! He is very smart and intuitive (from the poodle side) and very mellow and friendly (from the Lab side). He rarely barks, and is low shed and low allergy – pretty much perfect! He was trained as an autism dog, with tethering and tracking.

There are several benefits to using rescued dogs as service or therapy dogs: First, there is a much larger pool of potentials. Even a large scale breeder just can't have as many dogs in a year as a shelter sees. And 4 Paws works with several shelters to screen dogs that fit the profile.

Second, it is possible to avoid many of the genetic diseases that have come about because of puppy mills (my rule is, never get a breed of dog that had a Disney movie - they get too popular, and the dogs are the ones that suffer). Also, there is a much bigger range of innate talent some dogs are able to sense seizures - and there is no way to know or breed that trait. 4 Paws clients come in lots of different sizes with lots of different needs. For instance, hearing and seizure dogs do not need to be large breeds, but a dog that does tethering or assists with balance needs to be big (some of them are very big - it depends on the needs).

Emma actually doesn't have autism; she has a collection of other (read "weird") neurological problems. Because of them, she has many of the same issues that a child with autism faces. She has no

safety consciousness at all, and *loves* to walk down the yellow stripe in the road! She is an escape artist who can get past the locks, alarms, and deadbolts so she can go to the park, or wherever else she wants to be. She loves to get into strangers' cars, she loves men (especially mid-20s) and she can't talk.

Bubbles has been a life and sanity saver. I am not a "dog person," but Karen and Jeremy (leaders of 4 Paws for Ability<sup>TM</sup>, Inc.) matched him perfectly for our family. Emma doesn't even try to escape any longer because she knows it is pointless with him! She is *much* calmer, and her attention span

is longer. We have seen so many improvements that are hard to quantify, but the only thing that has changed in her life is the dog. She used to bite, pinch and pull hair when she was frustrated, and those activities have almost

frustrated, and those activities have almost completely disappeared. Bubbles sleeps in her bed with her, and she sleeps through the night now.

We feel so incredibly blessed to have found 4 Paws (I looked for the right trainer for a year before I found them). Everything about their philosophy was perfect for us. I don't mind that Bubbles is not pure bred. I love that 4 Paws uses shelter dogs, and that most of the dogs are trained by prisoners. They are wonderful about being available after the dog is placed, and helping with the adjustment.


Bubbles goes to Emma's church class and to school with her. I went in and talked to the children at church before we got him, and told them how to behave with a service dog. I taught the teachers at school and church Bubbles' basic commands, and I keep them supplied with treats. 

### Online Just Got Better .....

ave yourself a stamp and envelope – you are now able to Trenew your dues online via the Internet. Just click on the Join button from any Webpage, fill out the form and then click the Pay link. There are no additional charges to pay via the Internet. PayPal is used to make your payment, but you don't need a PayPal account - just a credit card. PayPal uses a secure connection, so you don't need to worry about using your credit card. This will likely be a popular feature - in the first day of operation, one new member joined and three renewed!

Also, a new experimental feature has been added to the Website – the DOAI Social Network. This is very similar to Facebook and other popular social Websites. Members are able to post pictures, videos, and their own blogs. Let others see your pictures, admire your D, and read about your travels. You can get to the site via a link on the Members Page or via the Forum button by clicking the Social Room (from the home page only for now). Come, take a look and have fun with it.

This time we focus on treats which are easy to fix. If you have a tried and true quickie treat recipe (or a great recipe using flour or corn tortillas), how about sharing it with everyone? Just send the information to the editor in an email, and you'll see your name in print soon.

#### Cinnamon/Sugar Crisps (Betty Bailey)

Ingredients: Flour tortillas; butter or margarine; cinnamon and sugar mixed together.

Lay tortilla on cookie sheet and lightly brush butter or margarine on top. Sprinkle with cinnamon/sugar mix and place in preheated 350° F. oven for 8-10 minutes (if you use a pizza stone, succeeding bakings will be a few minutes less). Remove and cut into strips. Let cool and enjoy.

Variation #1: Sprinkle garlic powder and grated Parmesan cheese; or sprinkle with shredded jack cheese and chopped green chilies (skip the butter), or sprinkle with a mixture of garlic powder and onion powder on the buttered tortilla and serve warm with salsa.

Variation #2: Spread homemade chunky applesauce on one tortilla, then top with another. Turn over edges and crimp. Fry lightly and enjoy the closest thing to apple pie without the calories and without the work.

#### Quick Turtles (Marion Becker)

Ingredients: Snyders® Butter Snaps or any brand ½-inch square (or round or whatever) pretzels; Rolo® chocolate and caramel candy rolls; pecan halves.

Lay pretzels on cookie sheet and top each with a Rolo candy. Place in preheated 350° F. oven for two minutes. Remove from oven and top with a pecan. Let cool and enjoy. ❖

### Fleetwood Technical Information

R eactivating your Discovery after long-term storage is more than just getting in and starting it up. It's important to be as careful in bringing your RV "back to life" as you were about putting it into storage. Remember that even though your coach may have been idle, its components and systems continue to age. The following checklist will help you prepare your RV for the first trip of the season. Be sure to follow all checklists prior to travel.

Fluid levels: Check fluid levels for oil, power steering, engine coolant, windshield washer, transmission, brake fluids, and house batteries. Also check your chassis manufacturer's requirements for any further needed inspections and fluid changes.

Air Conditioner, Furnace: Clean air conditioner filter and check both appliances for proper operation.

Awning: Extend to air out. Lubricate moving parts if necessary. Re-stow before travel.

Batteries - House and Chassis: Clean terminals following safety procedures; test all systems for proper operation.

Brakes: Check brakes for proper operation. Take to your nearest chassis RV service center if service is required.

Dump Valves: Knife valves should operate smoothly. There

should be no sticking, and knife valves should seal completely. Lubricate or change any suspect valve before a problem

Generator: Check oil and coolant levels, air inlet and exhaust for obstructions. Check compartment for debris. Start generator and

test for proper operation. Is the generator current on maintenance items?

**Leveling Jacks:** Extend and retract to ensure proper operation. Remember to have your engine running, to assure adequate power from the alternator, to assure proper operation. For hydraulic jacks, use a silicone spray to lubricate the cylinder surface and operate the system a few times to lubricate the seal edges. Inspect for hydraulic fluid leaks, also check hydraulic fluid level, if you are getting a jacks down signal on the touchpad when the jacks are fully retracted.

**Lighting:** Turn on all lighting systems; check for burned out bulbs or non-functioning fixtures. Replace or repair as needed. Be sure to replace with the same number bulb that was originally installed.

Roof: Check roof and roof sealants for cracks and repair as necessary. This procedure should be followed every three months.

Surge Protection Device: Consider adding a surge protection device to the electrical system, to help protect against 50 amp power fluctuations from shore power, or inadvertent loss of neutral if the power cord plug is inserted or extracted from a receptacle that is still "hot". ALWAYS turn off the shore power before plugging in or unplugging the shore

Slide Rooms: Check bulb seals and wipers seals, lubricate or have them replaced if the seals have lost their flexibility and are not properly sealing. Lubricate rams and gears under the

> Tires: Check tires for cracks or embedded objects. Check tire pressure and adjust to the tire manufacturer's load Remember, tire manufacturers suggest specifications. replacing tires with visible sidewall cracks and any tire that is seven years or older.

> Towing System: Examine the hitch system for wear, loose bolts, or cracks. Check wiring socket for corrosion, clean or repair as necessary.

> **Underbelly:** Check for rust, corrosion, leaks or other damages that may require repair. Do not undercoat near brake lines, fuel lines or exhaust systems.

> **Vents:** Clean and check for proper operation and ventilation. Appliances: Check for proper operation of all appliances, including checks for nests, spider webs, and debris at the burners and exhausts of the appliances.

> **Propane:** Have your local Fleetwood dealer perform a pressure drop test on the propane system to ensure you do not have any leaks.

> Fire Extinguisher: Reinstall if removed and verify that the fire extinguisher is fully charged.

> Safety Equipment/Appliance Batteries: Install new

batteries in clocks, smoke detectors, CO detectors, etc. Test all items for proper operation.

**Ventilation:** Open all windows and vents to air out coach. Remove sun block material.

Water System: Flush antifreeze from system (if winterized) then sanitize and add fresh water.

Sanitizing Procedure: To assure complete disinfection of your fresh water system, it is recommended that this procedure be followed on a new system, one that has been used for a period of time, one that may have become contaminated, or one that may be going into or coming out of storage for a period of time:

- Prepare a chlorine solution using one gallon of water and ½ cup of household bleach. With the fresh water tank empty, put the solution into the fresh water tank. Use one gallon of solution for each 15 gallons of fresh water tank capacity (example: a 75-gallon fresh water tank would require five gallons of solution to be put into the fresh water tank).
- Complete filling the fresh water tank with fresh water. Turn on the water pump and open each faucet and run until a distinct odor of chlorine can be detected at the water discharge. Do not forget the hot water taps and exterior faucets or showers.
- Allow system to stand for at least four hours.
- Completely drain and flush the fresh water system.

### **DOAI Forum Conversation**

#### Reverse Osmosis ...... by Linda Bethane and Bill Capers

Tot long ago, Linda posted a question and Bill posted a response on the DOAI Forum about reverse osmosis. There seems to be more and more Discovery owners investing in this type of system, so perhaps the following will help you:

**Linda wrote:** We are considering installing a reverse osmosis filter system in the entire coach. We spend the winters in Arizona and Nevada where everyone who owns a home has an RO system because the water is so bad. While we live in these areas, we drink only bottled water. So, we have started thinking that we too need an RO system.

My understanding is that not only will it provide good drinking water and clear ice cubes, it is also better for the entire plumbing system. It will keep fixtures and shower doors free of water spots. Do any D owners have the system and/or have thoughts on them? What pros/cons can you give me?

**Bill responded:** We have been running a whole house RO system in our RVs for the past eight years while in the Yuma area, and wouldn't take anything for it. When we bought our 2002 Discovery, I transferred it from the old SOB.

I have ours mounted in the same compartment as the water pump, and use it to fill the fresh water tank when we are in bad water areas.

In order to boost the water pressure capabilities of the RV, I replaced the original water pump with a ShurFlo Extreme 7.5 GPM pump, and have more than enough flow/pressure.

I also use the RO water to wash the rig, in order to eliminate the hard water spots from the local water. The system

we installed was designed for RV use, and has a membrane rated at 100 gallons per day, but that amount depends on the available water pressure of the inlet water. We normally get about 45 GPD from the local city pressure. Adding a high pressure pump on the inlet will increase the overall gallons per day; however, we have found we really don't need one, even with my better half doing two or three loads of wash each day.

When not in use, we remove the membrane and carry it in a ZipLoc® bag in the refrigerator to prevent it from drying out.

While the RO system we purchased was designed to be installed in an RV, a standard RO system found at The Home Depot or the like can be adapted for use in an RV.

Two critical elements for the RO system in the RV are the RO water being fed into the fresh water holding tank, and the disposal of the bypass water from the RO system into the drain. Getting the RO water into the fresh water tank can be as easy as running a 1/8-inch plastic tube from the membrane to the fresh water fill port, or piping it directly into the tank.

I simply installed a "T" in the fresh water vent line, and I fill the tank that way. However, a friend uses the first method.

Disposal of bypass water: it can be run into the sewer hose by using a tapped fitting into the sewer hose quick disconnect fitting. However, I *strongly* recommend a vacuum breaker be placed in this line to prevent any possibility of contaminated water being introduced into the fresh water supply.

The RO system can either be mounted permanently, or used as a portable arrangement. In our case, I mounted the system in the fresh water pump bay. This way, it is in an area where if there is a leak, it will do no damage, plus I can lift it up and remove it for winterization/service of the filters. Since the RO system can be mounted in any position, it can be placed on its side if necessary.

I purchased our RV RO system in Yuma several years ago for about \$400. If you are handy, the home improvement center version might be a better way to go. Granted, you might have to visit the local hardware store to get a few additional fittings, however on these systems, you normally get an accumulator tank, which is nice to have in the rig, and an RO faucet, which you would discard, since you would be using it as a whole house system.

I installed a two-gallon accumulator tank in the same bay as our RV RO system, and it works wonders.

You have to keep an eye on the amount of RO water that you put into the tank, otherwise you can get ready for some problems.

On our water tanks, which are mounted between the frame

rails, I forgot to monitor the water level. When I checked the tanks, I found that they had overfilled and the tanks were expanded all the way to the floor. Had I not noticed them in time, there is no doubt that I would have had floor damage.

Strange that when filling with a water hose, or using the tank fill valve, when the tanks are full, water comes out the overflow. But when using the RO system, the input is so slow that the tank

expands and never overflows. I think this is because the overflow is about three inches above the top of the tank, and the fill from the RO is so gradual.

I came up with a couple of ways to control the RO input to the fresh water tank. One method was to add a sensor to the tank that would control a water valve that would be turned off when the tank was full. This was a bit of an overkill, so I didn't follow up on it.

Instead, I simply bought a 9-volt battery-powered water sprinkler control from The Home Depot, and set it in two-hour increments. However, I still keep an eye on the water level, just to be safe. Unlike the house system, where there is a pressure valve that will turn off the RO system when your small tank is full, the non-pressurized fresh water tank on the RV won't allow this system to be used.

### **RV** Safety

#### Slide Prevention and Recovery .....

Having your vehicle go into a slide can be a scary thing. You can feel more comfortable behind the wheel if you understand what causes slides, how to prevent them, and what to do when you experience a slide.

#### What Causes a Slide?

A slide occurs when your tires lose traction on the roadway. The single biggest cause of slides is excessive speed – either because of the speed itself or from braking too hard when attempting to slow down. Excessively high side winds can also cause your vehicle to go into a slide.

#### Preventing a Slide

Reducing your speed and making slow, gradual applications to the steering wheel, brakes, and accelerator are the best preventive measures for avoiding a slide. Slow down prior to or when encountering slippery conditions. You should reduce your speed according to the type of condition being encountered. For example, you

should slow down more if you are driving on icy roads than on rain-slicked roads. A good rule of thumb for wet roads is to reduce your speed 20 percent from normal or posted driving speeds. Snow-covered roads require a 60 to 70 percent reduction from normal or posted speeds.

#### Types of Slides

Slides can be categorized into four types: braking slide, rearend-breaking-loose slide, momentum slide, and power slide.

#### **BRAKING SLIDE**

The first type of slide is a braking slide that occurs when the wheels lock up because too much pressure is applied to the brake pedal of a vehicle without anti-lock brakes. Even vehicles with anti-lock brakes can experience a braking slide under extremely slippery conditions.

If braking has caused the slide, quickly take your foot off the brake. Resume braking, but apply the brakes in a way that avoids locking the wheels. If you do not have anti-lock brakes, you may find a pumping action to be effective. Try to steer your vehicle onto a portion of the roadway that will give you more traction. Move your coach out of the path the tires are currently traveling so that the tires will have crust to grab a hold of. It's best to move to the portion of the roadway that is not traveled – it usually offers more traction.

#### REAR-END-BREAKING-LOOSE SLIDE

The rear-end-breaking-loose slide is another type of slide that can occur. This type of slide is caused by the application of too much power or traveling at too high a speed in a curve, which causes the rear end of the vehicle to try to come around.

If the slide occurs in a curve because too much power is applied to the rear wheels of a motor coach, ease your foot off the accelerator and shift the transmission into neutral until control is regained. If speed is the cause of the slide, a light application to the brakes will be required to reduce your speed

to a controllable level.

The third type of slide is called a power or torque slide. It is usually caused when a vehicle is stopped and too much power is applied to the rear wheels. Recovering from a power slide is very similar to recovering from a rear-end-breaking-loose slide. A power slide usually occurs when starting from a dead stop. The back end breaks loose to the right from torque applied to

the rear wheels, and can be stopped by simply removing your foot from the accelerator. Sometimes you can give your vehicle additional traction by lifting the tag axle if it is so equipped. This action applies several thousand more pounds to the rear of the coach and can often give you the traction needed to get moving. Remember, if you add weight to the rear end of the coach, you take it away from the front end. On a slippery road surface you also want maximum weight on the

front axle. Return the tag axle to its normal position as soon as the vehicle starts moving.

#### MOMENTUM SLIDE

The fourth type of slide is a momentum slide. The momentum slide happens when the weight and force of the vehicle works against the ability of the steering to change the direction the vehicle is moving. The result is that the steering wheels, i.e., the front wheels, on the coach lose their ability to grip the slippery road surface and begin sliding straight even though they are turned to the right or left.

The momentum slide is the most difficult slide to recover from. To do so, slow your speed down and get the front wheels to go in the direction they are pointed. Sometimes you can regain control by simply taking your foot off the accelerator and quickly turning the steering wheel in the direction momentum is carrying the vehicle. At this point, turn the wheels slowly in the direction you want to go and see if they will allow you to turn. You don't have much time to regain control. In other circumstances you can simply make a light application of the brakes and steer onto a portion of the road to get some traction. As a last resort, if you have this option available, you may be able to ease into a snow bank to get the vehicle stopped.

### Dr. Dometic Says...


Coutside your RV as the bright, yellow sun beats down on you. Feel its warm, hot rays surround you as your clothes begin to cling to your skin. Sweat begins to form on your neck and run down your back. You reach for your glass of ice tea to find that you've already downed its last quenching drop. Drenched in heat and discomfort, you retreat to your RV haven where the air conditioner is maintaining a cool, comfortable internal temperature.

"An air conditioner or heat pump is the workhorse of the RV, creating a consistent environment during your RV travels

so that you can escape from uncomfortable conditions," said Dr. Dometic, RV expert and enthusiast. "While it may draw the most power, it will provide the most comfort and usually requires minimal maintenance, providing many years of trouble-free service."

Periodic maintenance will help your unit operate at peak levels, while keeping the high temperatures outdoors. Washing your air conditioner's filter is an easy way to ensure a breath of fresh air during a routine RV cleaning. To do this, remove the return air filter located above the removable panel in the air box. Wash the filter with soap and warm water, let it dry and then reinstall it. Be careful not to run the air conditioner without the return air filter in place. Doing so may plug the unit's evaporator coil with dirt and may substantially

Also clean the air box housing and control panel with a soft cloth dampened with mild detergent. Be careful not to use



affect the performance of the unit.

harsh or abrasive chemicals such as furniture polish or scouring powders.

Under certain conditions, frost may form on the evaporator coil. If frost forms, inspect the filter and clean away any dirt. Also make sure air louvers are not obstructed. Air conditioners have a greater tendency to


frost when outside temperatures are relatively low. Adjusting the thermostat control knob to a warmer setting could prevent frost formation. Should frost continue, operate in a low, medium or high fan only setting until the cooling coil is free of frost.

Note that poor or improper airflow, short cycling, a dirty filter or placing the thermostat on its minimum temperature setting and the fan on low speed in high humidity situations can cause evaporator freeze-up.

"If for some reason your air conditioner or heat pump isn't working properly, there are a few checks that you can do yourself before calling a service technician," advised Dr. Dometic.

Before calling a service center, first check that your RV's generator is running and producing power. If the RV is connected to shore power, be sure the line is sized properly to run an air conditioner load and that it is plugged into the power supply. Also check your 115 VAC fuse or circuit breaker to see if it is open.



If the fan and/or the compressor won't run, test the AC voltage. To check your AC voltage when you arrive at your destination, plug into the shore power supply as you would normally. Place a voltmeter into a receptacle inside your vehicle and start your air conditioner or heat pump. When the compressor starts, make sure your voltage is over 103.5 volts. If the thermostat has no lights showing, it means that the unit isn't receiving DC power, so the 12-volt DC fuse and breaker

should be examined.

In the case that the fan runs and the compressor tries to start but won't run, then examine the exterior power cord, plug and receptacle. If those are in working order, carefully check the AC voltage at the power source.

If the fan runs, but the compressor cycles on and off and doesn't cool correctly, it could be improper or poor airflow, a dirty filter, dirty condenser, short cycling (a duct leak) or the AC voltage may be the problem.

Dr. Dometic advises calling a qualified technician if the compressor doesn't cycle at all. The technician should check the filter (which must be clean) and remove any debris from the condenser. The doctor also says that only a technician should attempt to repair a leak. The technician should examine the mounting bolts, roof gasket and condensation drain holes, and check to ensure condensation is draining properly.

"With proper maintenance and care, an air conditioner or heat pump can last a long time, but it is important to have periodic maintenance and repair tasks performed by a qualified technician. Check your owner's manual for details," Dr. Dometic explained.

Routine maintenance will keep your air conditioner or heat pump operating at top levels. Then you can bask in the warm sun and return to your cool, comfortable RV whenever you desire.
