With that behind us and fuel prices being what they are, we need to adjust our daily lifestyle. There are many things that we can do to help. I intend to keep camping and enjoying my D as I did in the past, with some adjustments. We can start with keeping our coaches in top running order, not only for fuel savings, but also safety. Check the tire pressure for the correct psi before each trip and at least once a week when not traveling. Use the cruise control and the economy mode, staying between 55 and 60 mph, which offers the best mileage for our coaches. Wash, wax, and polish as often as needed to cut down on friction, and using low-friction lubricants in the Cummins or Cat will help. The use of coach fans during moderate weather (and not the A/C) will conserve fuel and horsepower. If you enjoy the DOAI eGroup as I do, there are any number of ideas from members on this subject that will help. If you're not connected to the DOAI eGroup, contact Bob Cook, our super Webmaster, and he will get you connected.

Soon Discovery owners will come together in San Antonio for our annual national rally to renew their friendships with other Discovery owners, and enjoy all the great things in and around the city. The host chapters, Texas Disco Road Runners, Discovery Texans, and Louisiana Mudbugs, are planning for a great event. SAN ANTONIO – A TOP-NOTCH TRAVEL DESTINATION

The theme of the 2006 DOAI national rally is aptly named. The Alamo, or Mission San Antonio de Valero is the most famous spot in the city of San Antonio. It was here on March 6, 1836, after a 13-day siege by the army of Mexican President Gen. Antonio Lopez de Santa Anna, 189 defenders including Davy Crockett and Jim Bowie were defeated. Texas Army Gen. Sam Houston took up the rallying cry, "Remember the Alamo!" and Santa Anna was defeated on April 21, giving Texas its independence from Mexico.

The Alamo is located in Alamo Plaza, as are several other tourist attractions: The Guinness World Records Museum, Ripley's Haunted Adventure, Davy Crockett's Tall Tales Ride, The Plaza Wax Museum, and Ripley's Believe It or Not!

Within walking distance of the Alamo is the River Walk, or Paseo del Rio. For three miles, the San Antonio river is transformed into one large cultural center, shopping mecca, botanical garden, meeting place, culinary center, nightclub, and tourist attraction, all just below street level. It truly is the jewel of the city.

Did you know that even though San Antonio is completely land-locked, it has the largest SeaWorld marine wildlife park? This year Shamu premiered, and visitors have been enjoying his whale of a show. (Sorry...couldn't resist the pun.)

And cuisine! "There are 300 Tex-Mex restaurants in the Yellow Pages," says Dee Dee Toteete, PR director for the San Antonio visitors bureau. That means we can eat our fill of delicious food, and perhaps go back home a few pounds heavier, but happy!





ight now, while you're thinking about it, call the San Antonio Convention & Visitors Bureau at 800.447.3372 and request the San Antonio visitors packet be sent to you. You can also go online to www.sanantoniovisit.com and fill out a form. You'll receive a packet of information in three to six weeks.

The packet includes an informative guide to the River City, complete with details of location, days open, admission fee, etc. In the back is a fold-out detailed map of the downtown area of the city, with most of the important sights clearly noted.

While you're online, click on "Click here to open visitors guide" and you'll be taken to a page with a virtual guide to browse. If you have a fast Internet connection, you can download the book to read at your leisure. "Fast" is the operative word here...with a 56K modem it will take

approximately 61 minutes to download the booklet! But, if you've got time to spare, perhaps that's the way to go. Then you can print it out and have it 'way before a hard copy would reach you by regular mail.

While you're at the Visitors Bureau site, browse other pages as well. There's a lovely slide show, and if you click on any of the photos, you'll get an enlarged view. There are some very good shots of River Walk, the boat tour, zoo inhabitants, fiestas, and so on.

Click on "Maps" and you can download PDF files of a metro area map and a downtown map. Click on "What's New" and you can read about the reopening of Tower of the Americas, a 750-foot tall observation tower, second highest in the nation. Have fun browsing!

VERY IMPORTANT NOTICE TO MEMBERS: WEB SITE CHANGES by Bob Cook

he DOAI Web site contains a wealth of information for the Discovery owner. Historically, all areas of the Web site, except for the *eGroup* and the member database, have been open to everyone – including folks who own a Discovery but have not joined DOAI.

The Web site takes a great amount of work and many members contribute articles or information to assist other members. Member dues are essential to operate the Web site. The time has come to limit access to certain portions of the Web site to DOAI members only.

The Hints, Modifications, Bulletin Board, Members Database, eGroup, Chat Room, News

and *Newsletters* will be restricted to DOAI members only. **This change is effective July 20, 2006.** Other areas of the Web site will continue to remain open to the public.

When you click a link to a restricted page, you will be asked to sign in with your login ID and password. Your login ID is your DOAI member number, and your password is your last name. You will not be able to change your login ID or your password as the authorized user database is generated from the monthly member list. You will retain your current user ID and password for the *Bulletin Board*, but access to the entrance page to the *Bulletin Board* will require that you log in using your member number and last name.

FUEL PRICES RISING

Traveling with high fuel prices is a challenge for all of us. Do we park our Discovery and just stay home? Do we sell the "beast," and change our lifestyle and possibly lose a way of life we love?

I'm sure all of us have thought and worried over what is best for us. The days of cheap fuel are gone and we will not see them again.

So, how do we keep on trucking down the road? I guess the answer for many of us is to plan our RV adventures at a different pace than we have in the past.

From July 1 of last year to the present, I have traveled over 13,000 miles in my Discovery and yes, fuel was my biggest expense. So I guess the answer is driving less. But that changes our lifestyle a lot.

What I am going to do is still get to the places we want to see, but get there a lot more slowly than we used to. I'm driving more back roads than ever before and lowering my speed considerably – 55 to 60 is my new speed. Yes, the fuel economy is much better and we see a lot more along the road. The distance between stops will be less, and we will be staying longer in each spot as we travel and see this great land of ours. It may take more extensive planning than it used to and then again, maybe not – only time will tell.

We are not going to park our RV any time soon, but try to plan our trips more carefully, to get to all the places still on our list, while possibly returning to some of our old ones.

Happy RVing to all of you. I hope to see you on the road.

Note that the old login of *DOAI2* and password of *diesel2* will no longer be operational. The new login (your member number) and password (your last name) will be used to gain access to all restricted pages.

There are several free password manager programs (such as *Roboform*) that one can use to automatically remember and fill out login forms. This is an excellent way to keep from having to remember login info for any Web site.

The member validation process requires *JavaScript* on your browser. Most browsers enable *JavaScript* by default. If you have your browser set up to only allow *JavaScript* on selected sites, make sure that you allow the

DOAI Web site to use *JavaScript*. Internet Explorer users who have their browser security set to "High" will need to do this. You will not be able to view the restricted pages without using *JavaScript*. For your convenience, once you log in, you will not

need to log in again to view any restricted pages on the DOAI Web site until you close your browser. However, cookies must be enabled on your browser for this feature to work. If your browser is set to **not** accept first-party/originating cookies, you will want to put the DOAI Web site on your exception list to allow cookies so that you do not have to log in again to view a new restricted page. Cookies on the DOAI Web site <u>do not</u> contain any spyware.

- **RV Dump Stations:** For a complete listing of RV dump stations near your travels, go to *www.rvdumps.com/*. The Webmaster welcomes additions to the list, and it is updated frequently. Recent additions were stations in Westminster, California; Meridian, Idaho; and Muscatine, Iowa.
- Free WiFi Listings: The DOAI Web site includes a spreadsheet of free WiFi listings, now numbering about 600 verified sites across the country. You can link to the listing from DOAI's main page. For more about free WiFi, go to www.wififreespot.com/.

FLEETWOOD TECHNICAL INFORMATION: MOTOR HOME BATTERY MAINTENANCE AND TIPS

Notice the fluid level of each cell every seven days. If you are not a regular user, it is important to check the fluid level of each cell at least once a month. The following is a list of recommendations from the Trojan Battery Company:

Inspection

- 1. Examine the outside appearance of the battery. Look for cracks in the container. The top of the battery, posts, and connections should be free of dirt, fluids, and corrosion. If batteries are dirty, clean them as specified below. Replace any damaged batteries.
- 2. Any fluids on or around the battery may indicate that electrolyte is spilling, leaching, or leaking out. Leaking batteries must be replaced.
- 3. Check all battery cables and connections. Look for loose or damaged parts. Replace any cable that is broken or frayed.

Watering (Flooded batteries only)

Prior to charging the batteries, there should be enough water to cover the surface of the plates. Otherwise, water should only be added after fully charging the battery.

Important Things to Remember

- 1. Do not allow plates to be exposed to air.
- 2. Do not fill the water all the way up to the cap.
- 3. Do not use water with high mineral content.
- 4. Use only distilled or de-ionized water. **CAUTION:** The electrolyte is a solution of acid and water, so skin contact should be avoided.

Procedure

a. Remove the vent caps and check the electrolyte level: the minimum level is to the top of the plates.

b. If there is no electrolyte visible, add just enough water to cover the plates.

c. Replace and tighten all water vent caps.

New Freightliner Service and Training Facility by Marshall Godwin

In keeping with their goal to provide the best service possible, Freightliner Custom Chassis has a new Factory Service Center in Gaffney, South Carolina. The service center is located on Spartanburg Technical College's Cherokee Campus at I-85 and Highway 11 (near the big peach water tower). By the time you read this article, the facility will be open and operating.

The new facility is a joint venture with Spartanburg Technical College. Besides quality service for owners, the partnership will train and certify technicians to service d. Completely charge the batteries before adding any more water.

e. Once charging has completed, remove the vent caps and check the electrolyte level.

f. Add water until the electrolyte level is 1/8" below the bottom of the fill well.

g. Clean, replace and tighten all vent caps. **WARNING:** Never add acid to a battery.

Cleaning

- 1. Check all vent caps to verify they are tight.
- 2. Clean the battery tops with a cloth or brush and a solution of baking soda and water. Do not allow any cleaning solution or other foreign matter to get inside the battery.



3. Rinse with water and a dry clean cloth.

Storage

- 1. Freezing: Avoid locations where freezing temperatures are expected. Keeping batteries at a high state of charge also prevents freezing.
- 2. Heat: Avoid direct exposure to heat sources, such as radiators or space heaters. Temperatures above 80 degrees Fahrenheit accelerate the battery's self-discharge characteristics.

Procedure

a. Completely charge the battery before storing.

b. Store battery in a cool dry location protected from the elements.

c. Check charge and the condition of the batteries monthly.

GETTING THERE SAFELY

by Mark J. Polk Orty thousand people in the United States die each year on the road! With the peak RV travel season quickly approaching, I thought this would

be a good time to discuss getting to your RV travel destination safely. Getting there can be half the fun, as the saying goes, if you take a few precautions to make your trip safe.

The first step is to plan the trip you are taking. Travel guides, magazines, state tourism boards, and Internet sites offer valuable information to help you plan your trip. Route your trip on a map or from an Internet trip planning site. Always keep an atlas or maps in the RV or tow vehicle. Driving a motor home can be stressful, especially if you don't know the route you will be traveling. Using a GPS system can make traveling much less stressful.

Complete a pre-trip checklist before you head out on the road. Simple checks like checking your tires, lights, hitch work and other items, all contribute to a safer trip. You should make these checks every day before traveling.

Take plenty of breaks when you're traveling. Stopping, stretching out, and taking brief walks can revitalize you. Do not rush to get to your vacation destination. Driving too fast and for long periods of time can result in fatigue and falling asleep at the wheel. If you feel tired, you should pull over and rest or change drivers. It's a good idea to switch drivers every few hours. Keep a window cracked open to help you stay alert, and only eat light meals when you stop to eat.

Avoid driving your RV during bad weather and high winds. Because of the size and mass of RVs, it can be extremely dangerous to travel during periods of high winds. It's better to get to your destination one day later, than to risk traveling in bad weather.

Limit your driving time to five or six hours a day (300 to 350 miles). Not only will you be more alert, but you will arrive at the campground with plenty of day light to get set up and settled in before it gets dark outside. This gives you a chance to unwind and get rested for another day of travel, and to enjoy some of the amenities the campground has to offer.

Drive defensively! Stay alert and monitor what is going on around you at all times. Use your mirrors. For increased visibility, purchase some convex mirrors that you can stick on your side view mirrors. These mirrors are inexpensive and are available in auto parts stores. They come in different sizes and will improve your visibility a great deal, especially along the sides of the RV and in blind spots. Eventually you will have to pass another vehicle in your RV. It's not difficult to pass but with a large RV, it requires more space and time than the average automobile. Make sure you have plenty of room and use your turn signals to change lanes. Accelerate until you are past the other vehicle and you can see both of their headlights in your mirror. Signal again to return to the other lane and pull back in. Maintain your speed ahead of the vehicle you just passed.

Always leave plenty of room between you and the vehicle in front of you. RVs are much heavier than your automobile and require a longer braking distance to come to a stop. This alone will prevent accidents, especially during emergency braking. Driving at a safe speed also lowers your braking distance. Always use a supplemental braking system on the vehicle you are towing, too.

Cell phones are nice to have for emergencies, but they can distract the driver. Do not use a cell phone if you are driving. If you must make a call, have someone who is not driving do it for you.

Never drink and drive!

In a recent study these dates, ranked in order, were identified as the ten deadliest days of the year to drive. Mark these on your calendar and stay put on these dates. One more day at the campground or getting to your destination one day later can't hurt you, but driving on these dates could do much worse. As you can see, most of the dates are close to, or on a major holiday. The reason for the August dates is because August is the busiest traveled month of the year.


REPLACING DISCOVERY'S JACK SEALS

eplacing the seals in a D's jacks can be expensive, but putting up with leaking jacks can be an embarrassing pain. Power Gear will want around \$400 for four jack seal kits, and the labor cost to remove, repair, and replace the four jacks, and the oil, would be horrendous. We've just completed doing ours for a total cost of \$10 for the seals and \$20 for oil, to drain and refill the oil tank. Actually we only needed to replace the seals in one rear jack and one front jack, but we now have replacement seals for the other two jacks, in

wipe dirt off the cylinder rod as it

retracts, and they install a grease

nipple that allows grease to be pumped in above the wiper seal. We figure since our original seal arrangement lasted eight years, we couldn't see the value in paying over \$400 to change to the new sealing arrangement, when we could buy

replacement seals for just \$10. Removing the rear jack proved the most difficult part, followed by removing the front jack; they are heavy and awkward and tightly bolted. Replacing those jacks is a bit difficult, too. Almost everything else is pretty straightforward. The Power Gear's jacks information document can be found at http://www.powergearus.com/DATA/seal%20kit%20manual %20%20rev%206.pdf, and is also available on our DOAI Web site. It clearly lists the tools required and the work procedure for overhauling the jacks. Remember to refill the hydraulic tank with Dexron III. That's a bit awkward, because it's hard to tell how much oil is required: too little and the jacks will not extend, too much and they will not retract fully.

Each of our D jacks has a rod guide/seals support screwed into the bottom of the jack cylinder. These are fitted with one inner moving T seal, against the cylinder rod, and one outer static O ring, against the cylinder bore. Each seal has one backing ring. It's our understanding that T seals are normally

used to discourage rotation of an O ring seal in situations where there is a lot of cylinder movement, such as to cause the seals to get hot and potentially stick to the rod. We understand that in the case of a D, a normal O ring seal will work just as well as a T seal. T seals are available but not normally stocked in a hydraulics shop. By comparison, O rings are readily available.

T seals will cost around \$7 each, compared to \$1 for an O ring. For our D, the O ring seal numbers are (for the rear jacks): 337 (inner) and 237 (outer); and (for the front jacks): 331 (inner) and 231 (outer). These numbers conform to a National Oil Seals Standard.

Remember that you need one backing ring for each seal. The seal numbers include those backing rings. Often two backing rings are used for each O ring, but only one is used for each O ring in our D jacks. If you really want to stick with the original T seal arrangement, then you can buy T seals to match the aforementioned O ring numbers.

In the next issue, Rod and Pauline will share a modification made to the exhaust brake system on their rig, complete with a schematic drawn for us on the computer by Gene Hamelman.


There are days when you just can't win.

the problem to a customer service supervisor.

4. If you are unable to get the problem satisfactorily resolved working with the customer service supervisor, call Fleetwood Customer Service again and report the problem to the customer service manager.

5. If you are unable to get the problem satisfactorily resolved working with the customer service manager, contact your DOAI region vice president. The region vice president will gather information from you to fill out an *Owner Reporting Form* and will send a copy to the vice president of

development, who serves as liaison to Fleetwood management.

6. Fleetwood management will review the report and contact you directly to attempt to resolve the issue.

While at first glance this might appear to be a long process, it does follow a logical progression to allow problems to be corrected at the lowest level of authority within Fleetwood's customer service organization. The steps can be done in a relatively short time. When followed, satisfactory results can occur at any step in the process and may well be obtained before it is necessary to submit an *Owners Reporting Form*.

I have noted problems reported on the DOAI bulletin board or eGroup with great detail, and no small measure of frustration on the part of a member, only to discover the owner never reported the issue to Fleetwood. Our members are an outstanding source of information to help correct issues, but if you need Fleetwood's help, please use the developed process, as it is your best chance to have Fleetwood promptly resolve problems.

There seems to be a tendency for us coach owners to want to hold the coach builder responsible for anything that goes wrong, regardless of how long we have been out of the warranty period. On a case-by-case basis, Fleetwood has taken care of problems outside the warranty window as a customer accommodation. I know of a number of such cases. However, please remember they run a for-profit business and there will be times when the simple answer is "No." On the other hand, valid problems need to be addressed and corrected. Be persistent in your efforts to get satisfaction, but remember that it helps to do so in a manner that focuses on facts rather than emotions. Your dedicated effort to correct your problem may well benefit many other Discovery coach owners with a similar problem.
